



PRIVACY POLICY – FOODEAZE.CA by Foodie Kids Inc

Foodeaze.ca by Foodie Kids Inc. recognizes the need to protect personal information that is provided to us by schools or directly through our website.

When you register and/or place an order through our web site, personal information is stored in our database for the following purposes:

1. Labelling meals to ensure the correct meal is provided to the correct individual
2. Identifying preferences such as those with allergies and/or dietary restrictions so that they do not receive food that they cannot consume
3. Ensuring quality and ordering control
4. Customer service such as resolving any future complaints about incorrect food orders

We will not use or disclose personal information for purposes other than those for which the information was collected, except with your consent or as required by law.

We will retain personal information only for as long as is necessary to fulfill the purposes for collecting such information. Upon request, we will inform you of the existence, use and disclosure of your personal information and you will be given access to your personal information, subject to any legal restrictions.

You may verify the accuracy and completeness of your personal information and may request that the information be corrected or updated, if appropriate.

All personal information received is treated as strictly confidential. Personal information will not be made available to third parties ever. Personal information may be aggregated for administrative purposes, and to conduct statistical and market research. Information received through our website may be used to inform you about upcoming offers and promotions unless you have explicitly indicated you do not wish to receive communication from us. This option is available in your profile.

We will not sell, trade, barter or exchange for consideration any Personal Information obtained. We endeavor to maintain adequate physical, procedural and technical security with respect to our offices and information storage facilities to prevent any loss, misuse, unauthorized access, disclosure or modification of Personal information. We further protect Personal Information by restricting access to it to those employees who need it to carry out their duties. Employees are informed of the importance of protecting your privacy and are expected to maintain the confidentiality of client information at all times.



The personal information we gather and store in our database is as follows:

- Your name (the name you use to register with)
- Your email address (the email address you use to register with)
- A password (the password is encrypted in our database and we can not see your password)
- Your phone number
- Your child or children's names (those names you use to register your child)
- The school your child attends
- The grade/division your child is in
- Your orders and order history

We do NOT store any payment information.

Our web site and database is hosted on a secure server with industry standard security features and measures. We rely on third-party vendors for these services and rely on their security protocols as well as our own to protect our data.

As with any on-line publicly available web site and data, the possibility of a security breach, though small, is always present. In the event such a security breach occurs, we will notify all users as quickly as possible and to the best of our abilities.
